conclude this **Agreement on Using mojeiD Service for Logging into Provider's Systems** (hereinafter as "Agreement") in accordance with the provision of Section 1746 par. 2 of Act No. 89/2012 Coll., the Civil Code.

1 SUBJECT OF THE AGREEMENT

- 1.1 The Parties conclude this Agreement in accordance with the provision of Article 2.4 of the Terms of Use of MojelD Service for Logging into Providers' Systems (hereinafter "Terms").
- 1.2 CZ.NIC hereby commits to allow the Provider to use all the benefits resulting from the Terms for a provider with full access.
- 1.3 The Provider commits to allow logging into the systems stated herein through MojelD service.
- 1.4 The Provider commits to pay the price to CZ.NIC according to the valid Price List issued by CZ.NIC, in the manner prescribed in the Price List. Failure to pay the price is considered as a material breach of the Terms. In the event of failure to pay the price for the Service CZ.NIC shall be authorized to suspend provision of the Service.
- 1.5 The Provider accepts the terms arising herefrom and from the Annexes hereto without reservations.

4.1 In the event of any contradiction between this Agreement and the Annexes hereto the Agreement shall prevail.

4.2 Unless stipulated otherwise herein the provisions of the Terms shall apply.

4.3 This Agreement is made in PDF format and provided with electronic signatures of the representatives of the contracting parties. Each Party shall receive this copy.

4.4 Mutual rights and responsibilities of the Parties that are not expressly regulated in this Agreement shall be governed by the generally binding legislation of the Czech Republic, especially Act 89/2012 Coll., the Civil Code.
